

TOWN OF CHARLTON BUILDING PERMIT PROCEDURES

1. Complete 4 copies of the application, attaching 4 copies of any appropriate forms e.g. plot plan or perc test, plans. All forms must be folded to fit a letter size file folder with application on top. These should be 4 separate files (sets).
2. Return all completed forms to the Zoning Administrative Office for review.
3. After project approval by building inspector, receive and post permit.
4. Once project is complete, a Certificate of Occupancy (CO) or a Certificate of Use must be obtained from the Zoning Administrators Office. **Allow 7 – 10 days for completion of this process after final inspection by the Building Inspector.**

BASIC REQUIREMENTS FOR INSTALLATION AND INSPECTION OF INDIVIDUAL HOSEHOLD DISPOSAL SYSTEMS

(PERMIT REQUIRED)

Septic Tank	Minimum 1,000 gallon concrete – Minimum 10 ft. from dwelling. Line from dwelling to tank – Cast iron or schedule 40 PVC (min. ¼ in. pitch) per foot. Line from tank to district box (min. 1/8 in. pitch) per foot
Headers	4 in. solid pipe
Field Lines	4 in. perforated (0 in. to 1/16 in. pitch)
Trenches	Min. 24 in. width – 24 in. dept All joints at tank and district box must be cemented. The end of leach lines must be capped or looped. #2 or #3 stone in trenches covered with untreated paper (building paper).
Inspection	All above installation procedures are to be verified. Two to three ft. of each end of all leach lines are to be left uncovered. Water will be put into the district box to check level of outlet lines to assure even distribution. If there is a problem with cement or caulk, be sure to allow time for drying. Figure this into your cost.

NOTE: Septic System Design Shall Include Consideration of Any And All Wetland Regulations

There will be a charge for a second inspection if not ready.

There will also be a penalty for working without a permit

4. The permit will be revoked in the event that a false statement appears
5. The building permit is issued in conformance with the requirements of the Charlton Zoning Ordinance, and the NYS Uniform Fire Prevention and Building Codes
6. Driveway must comply with the Highway Department specifications
7. Applicant must contact Zoning Officer & Building Inspector for final inspection and to obtain a Certificate of Use/Occupancy **before** use or occupancy of permitted work
