## **TOWN CLERK'S REPORT**

Town Clerk – Clerk Mills said for the month of September, the Town Clerk's office took in \$2,110.00. \$550.06 was paid to the Supervisor's office as revenue, and \$1,559.94 was paid to other Governmental agencies

#### SUPERVISORS REPORT

## **Announcements:**

Fall Brush Pick-up is scheduled for the week of October 30th. Have brush curbside by October 29th.

Bagged leaves will be picked up week of November 3rd. Have bags out by November 2nd.

The Saratoga County Department of Aging and Youth Services will be holding two public hearings. One is scheduled for October 19<sup>th</sup> at 1:00pm at the Galway Town Hall and the other is scheduled for October 31<sup>st</sup> at 12:30pm at the Town of Halfmoon Town Hall.

#### **Communications:**

The Town has received the resignation of David Pohl as Chairman of the Parks Committee. Supervisor Grasso thanked him for his many years of service.

The Town has received an invitation from the Ballston Lake Emergency Squad to their installation banquet. Councilman St. John and a guest plant to attend on behalf of the Board.

Supervisor Grasso said that he has received a request for a speed limit reduction request for the Northern section of Peaceable Street. The resident said that the road is currently unposted and they would like to see it be 45 mph.

## **Town Updates:**

Supervisor Grasso said that he has given the 2024 Preliminary Budget to the Town Board and the Town Clerk. The Clerk will put the budget on the website. The budget process includes; on Sept. 25<sup>th</sup> the Tentative budget was issued, the Board held a workshop on Sept. 28<sup>th</sup> and a few changes were recommended which have been included in the Preliminary budget, a public hearing will be held on October 23<sup>rd</sup>, and the Board will vote on the final budget on November 13<sup>th</sup>.

Some of the changes that were made after the tentative budget and included in the preliminary budget are an increase to the General Fund and the Highway Fund because of the projected increase in Sales Tax revenue next year from our original amount of \$1.6 million to \$1.65 million. That will result in a \$20,000.00 increase to the General Fund revenue, and a \$30,000.00 increase to the Highway Fund revenue. Also an increase was made to the Ambulance District tax from 2% to 3%. The budget summary sheet includes the budget amounts of all three of the Fire Districts that serve Charlton.

The preliminary budget includes the change to Sales tax revenue from \$640,000 to \$660,000 in the revenue line. There was an increase to the salaries of the Town Board members and the Supervisor. The Contingency line was raised from \$56,304 to \$70,304. Employee benefits-state retirement was raised from \$31,000 to \$32,000. The Highway Department revenue line was raised from \$96,0000 to \$990,000. An increase was made to the expense line from tree removal from \$14,516 to \$44,516.

The Preliminary budget includes a 3% increase for the ambulance service providers, bringing their amounts to: Galway \$52,386.00, Ballston Lake EMS \$41,076.00 and Community Corps. \$2,760.00. The total of the three is \$96.222.00.

The Fire Districts have released their proposed budgets which have been posted on the Town website. Residents are encouraged to contact their respective Fire Departments for information regarding the budgets.

#### **Financial Updates:**

The Mortgage Tax for September is \$6,564.50. The year-to-date Mortgage tax amount is \$72,854 which is only 65% of the projected budgeted amount.

The State Comptroller's Office sent notice that the August Court fees collected were \$4,864.00. \$2,604.00 was remitted to New York State and the remainder stays with the Town.

# **County Updates:**

The County has put out notice for property owners that want to join the Saratoga County Ag District 2. The inclusionary period is the month of October. Interested residents can contact the Saratoga County Office of Planning and Economic Development.

The Saratoga County Treasurers Office has issued their 2024 Sales Tax projections. The Full Market value of Saratoga County is expected to rise 13.62% in 2024 to 31.22 billion dollars. The County divides the sales tax with the Towns based on their share of the Full Market values. The Town of Charlton's Full Market value is expected to rise 14.91% next year, so we will be receiving a higher portion of the sales tax because of the higher Full Market value. The Town's equalization rate was 63% in 2023 and was lowered to 55% for 2024.

## Councilman Tasse, Liaison:

Town of Ballston Community Library - report read by Director Rebecca Verhayden:

The Library is holding a Public Hearing to discuss the charter update and proposed budget on Wednesday, October 11 at 7:00 PM. Residents of the Library District will have the opportunity to vote on the 2024 budget and election Trustees on Tuesday, November 14. Polls will be open 7:00 AM – 9:00 PM at the Library. The Library has several upcoming events for adults. We are partnering with Sorella Spa to offer a series of fitness classes at the Library on Thursdays at 9:00 AM starting October 5. We are also offering two upcoming computer classes; Graphic Design Tools on November 6 at 10:00 AM and Cloud Storage on November 13 at 10:00 AM. There will be a program on the History of Sports on November 16 at 6:00 PM. The Library will also offer Holiday Back Drops in November and December for people who wish to take their own holiday photos.

Councilman Tasse reminded residents that as winter is approaching and people are turning on their heat, it is a good time to check their carbon monoxide and smoke/fire detectors.
