COUNCILMAN COMMENTS

Councilman Robbins said that the Town has applied for a Trail Grant from the County and plans to extend the trail at Elmer Smith Park. It was discovered that the north end of the trail has an area that is too wet, so they will be shortening the loop extension. The Highway Superintendent is looking at how the work will get done and if machinery needs to be rented. The grant is a matching grant, so the Town must expend money or manpower. Residents have had good comments about the current trail.

Councilman Ranaletto asked if any progress was made on the Enable invoices. Supervisor Grasso said that he has been reviewing the past years invoices and he has some questions to go over with Chris Tasse. Councilman Ranaletto also said that the BHBL Summer Rec program has been growing and Andy Haluska has been doing a nice job running the program.

Councilman Glavin said that he met with the water clerk. They have not received the 20th sample test results yet. The letters sent to the delinquent water customers resulted in payments of over \$2,000.00.

PRIVILEGE OF THE FLOOR

Councilman Dave Robbins said that he would like to acknowledge the efforts of the outgoing Board members. Regarding Jenna Smith, he said that you could not ask for a better person for which to serve. Her intelligence, passion, and sense of humor has been a joy. He knows that he will miss her, the Board will miss her and he wants everyone in Town to know the value and rare resource that we are going to be moving forward without.

Councilman Dave Robbins said regarding Doug Ranaletto, he has been a great mentor and friend. He appreciates his no-nonsense, straightforward approach to business, intolerance for fluff and wasting time. He is a man of class.

Supervisor Grasso acknowledged Jenna Smith and said that she has been a valuable asset to the Board. She has been the lead on all things land use, which is a difficult role, and she has taken it on with a lot of professionalism. Her legal acumen has been very valuable and very insightful. She does her research and homework and put in tremendous effort to help us be a better Town. She was fun to work with and she will be sorely missed.

Supervisor Grasso acknowledged Doug Ranaletto, and thanked him for serving over 4 years on the Town Board. He said Doug is a consummate professional with a no-nonsense approach, an intellect on personnel and management issues and an advisor and mentor.

Town Clerk Mills said that Bob Killeen phoned the office and asked her to thank the outgoing councilman.

Councilwoman Jenna Smith thanked Supervisor Grasso and the Town Board for putting the best interest of the Town first, when they appointed her to the Town Board. She said it was an honor to serve the Town's residents and she wished the new Board members the best of luck moving forward.

Councilman Doug Ranaletto thanked the Town Board and the many employees that he has worked with and that have helped him over the years. He wanted to thank Alan Grattidge as well as Supervisor Grasso. He said it has been a pleasure being involved with the Town for the past 10 years.
