## **ANNOUNCEMENTS**

The Town is offering the 5 Hour Defensive Driving Course to employees. The course is mandatory for employees driving Town vehicles. Town employees are also required to annually take a Sexual Harassment course and a Workplace Violence course. Supervisor Grasso said that his secretary is working on setting up the courses on-line for employees.

The Town Board annually audits each Town Department that handles money. The Board members will pair up and schedule appointments with Department heads to begin the audits.

The Town received another limited supply of Covid test kits. The Town Clerk said that she sent out an e-mail blast and most of the kits have already been reserved.

Supervisor Grasso said that Town has gotten final rule changes on the ARPA funding. The new rules offer more flexibility with the funding as much of the funds are now considered unrestricted. Supervisor Grasso said that the Board will look at using some of the funding for items/projects that have been deferred. One item is the new police car that the Board will be voting on tonight.

# **COMMUNICATIONS**

Supervisor Grasso serves on the Saratoga County Board of Supervisors and said that this year he has been appointed to the following Committees at the County level: Law and Finance, Human Resources and Insurance, Economic Development, Buildings and Grounds. He has also been appointed as Chairman of the Trails and Open Space Committee.

The Town Justices receipted \$8,796 in fines in November. Fines collected from Justice Ketchum were \$2,730 and \$6,066 from Justice Hart. \$3,984 was paid to the State.

Supervisor Grasso said that the Town of Ballston has completed their draft of their Environmental Impact Statement. It is on their website and available for public comments.

Councilman Glavin reported for the Water Department - NYSDOH has responded to the Town of Charlton after receiving Lead and Copper testing results. NYSDOH has granted the Town permission to resume testing at former frequency of every 3 years and 10 testing locations versus 20.

Councilman St. John gave the monthly report (January) of the Planning Board:

- Heflin waiting for DEC to evaluate wetland maps submitted by the applicant before next steps.
- DeSantis Lot change application accepted
- Caruso Applicant missing info, Chair Wilkinson will reach out directly before moving forward with application
- Davidson Applicant will work with surveyor to submit a lot plan designed to mitigate impact on existing wetlands
- Bagden applicant wishes to convey property to family member, public hearing will be held in February

Councilman St. John said that Charlton Policeman Gary Parks recommends the old police car be liquidated by placing it for sale at the highway garage and advertise online. If an auction is the chosen form of liquidation, Gary recommends putting a reserve on the vehicle.

# RESOLUTION TO HIRE CAROL A. GOLDEN, CPA TO PREPARE TOWN REGULATORY FINANCIAL STATEMENTS FOR THE YEAR ENDING DECEMBER 31, 2021

WHEREAS, the Town is required to have regulatory financial statements prepared each year and is in need of having such done for the year ending December 31, 2021, in the form prescribed by the Office of the State Comptroller (OSC) based on the records kept by the Town's bookkeeper; and

**WHEREAS,** the Town, in previous years, has used the professional services of Carol A. Golden, CPA, of 714 Middle Road, Horseheads, New York, 14845; and

**WHEREAS**, the Town has received a new proposal from Carol A. Golden, CPA, estimated in a range from \$2,600.00 to \$2,900.00, to perform said work, which meets all of the Town's criteria

and specifications for said regulatory financial statements for the year ending December 31, 2021; and

**WHEREAS**, the Town Board believes Carol A. Golden, CPA to possess the necessary expertise and abilities, and to be the best choice to perform the work, at a reasonable cost and best value and expense to the Town, and is of a known quality and already familiar with the Town's finances.

RESOLUTION TO APPOVE THE PURCHASE OF A 2022 DODGE DURANGO FOR THE TOWN OF CHARLTON POLICE DEPARTMENT AND DOG CONTROL OFFICER

**WHEREAS**, the Charlton Police Department has advised the Town Board that due to the aging condition and the expensive repairs to the existing 2013 vehicle that is being used by the Town of Charlton Police Department, it is necessary to replace such vehicle with a new vehicle; and

**WHEREAS**, additional need and use for the new vehicle will be to provide transportation for the Town of Charlton's Dog Control Officer to safely transport dogs when needed and required; and

**WHEREAS,** the Charlton Police Department has obtained a proposal for the new vehicle purchase, and a proposal for the required police accessories (lights, sirens, lettering, etc.) plus installation, copies of said proposals are shown on the documents attached hereto and presented to the Town Board by the Charlton Police Department; and

**WHEREAS**, the Charlton Police Department has recommended to the Town Board, that the Town purchase a 2022 Dodge Durango, and the purchase and installation of the required police accessories, as set forth on the attached documents.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Supervisor is hereby authorized to enter into contract for the purchase of a 2022 Dodge Durango in the amount of \$39,201.00, from Main Motorcar, 224 West Main Street, Johnstown, New York, 12095, plus the purchase and installation of the required police accessories from Pittsfield Communications Systems, Inc., 18 Wade Road, Latham, New York, 12110, in the approximate amount of \$5,743.00, for the total amount not to exceed \$46,000.00, plus any incident expenses associated therewith, as set forth and described on the attached documents, and be it further

**RESOLVED**, that the Town Supervisor is hereby authorized to expend the sum of up to \$46,000.00, plus incidental expenses associated therewith, in order to pay for the purchase of the 2022 Dodge Durango, and the purchase and installation of the required police accessories, plus taxes and incidental costs; and to do all things necessary and sign all documents required in order to effectuate same.
