The Town received a large supply of Covid test kits which are available to residents at the Town Clerk's office.

Supervisor Grasso said that Town has received public notification of a proposed solar power generation project in the Town Florida.

The Saratoga County Planning Department has notified the Town a required 8-year review of the Saratoga County Consolidated Agricultural District #2 was begun In January 2022 and will be completed by November 17, 2022. The Town received notice because the Town contains certified parcels within this District. A map was provided and is available for public inspection. More information is available on the County website at: www.saratogacountyny.gov.

The Charlton Seniors have invited the members of the Town Board to speak at their April 13<sup>th</sup> meeting which begins at 9:30 a.m. The Senior's Meeting will be held at the Town Hall.

Councilman Robbins said that a committee for the Community Center met 2 weeks ago and had a good meeting. Jenna Smith was chosen as Chairperson for the committee.

Supervisor Grasso said that the December 2021 Financial Report has been given to Town Board members. The report shows that the account balances grew substantially from 2020, due in part from DOT bridge project reimbursements, Covid cost controls, rebounds in sales tax revenue and partial receipt of ARPA funding. **RESOLVED,** that this restriction and limitation shall take effect as of the date of this resolution and such restriction shall become effective upon posting of such highways by the Superintendent of Highways or his designee; and it is further

**RESOLVED,** that such limitation shall continue in effect until such time as conditions permit the withdrawing of the order; and it is further

**RESOLVED**, that notice is hereby given that any person or persons violating this order shall be subject to enforcement as provided in §1800 of the New York State Vehicle and Traffic Law.
