COMMUNICATIONS

The Technology Committee is in the process of forming a Broadband Committee to reach out for the underserved residents. If any residents are interested in serving on the Committee, please contact Chris Tasse or Councilman Glavin.

Councilman Glavin said that the \$7,100 grant awarded to the Town from the County Economic Development Agency will be used to focus on broadband.

Councilman Glavin said that the Department of Health has approved the Town's water sampling plan.

Councilman Glavin urged residents to sign up on the Town website to receive news from the Town.

The Town has asked Charter Communications for the cost to provide service to six underserved areas of Town. One area is part of Stage Road, Cook Road, 3 segments of Route 67 and Rocky Ridge Road.

The Saratoga County Clerk has announced that April 9th is Yellow Ribbon Day. Money and items are collected for our deployed troops. More information will be posted on the Town website.

The March Sales Tax amount was \$95,100.00 which is down 5.94% from March of 2020. The Supervisor said that he is closely monitoring our tax income. Because of the pandemic and the slowness of grant reimbursement from the State, tonight the Board will vote on a resolution for an inter-fund loan from the Highway fund to the General Fund. The Supervisor also reported that the beginning Fund balances in February was \$1,787.921.77 and the end of February balance was \$1,511,102.42. A payment of \$276,000 to William J. Keller for the Peaceable Street bridge replacements was a large reason the balance is lower. Reimbursement of the same amount is expected from New York State.

The annual Dog Control Inspection Report was received and Charlton rating was Satisfactory.
