The Regular Meeting of the Town Board of the Town of Charlton, Saratoga County, New York was held at the Town Hall, 758 Charlton Road, Charlton, NY and called to order by Supervisor Grasso at 7:35 p.m.

The Pledge of Allegiance was recited.

PRIVILEGE OF THE FLOOR FOR AGENDA ITEMS

No one chose to speak.

SUPERVISORS REPORT

Supervisor Grasso said that he attended many County meetings last month, including: Law & Finance Committee, Economic Development Committee, HR and Insurance Committee and the Buildings and Grounds Committee. He stated that the Buildings and Grounds Committee is working on a facilities space planning project, put out RFPs, and after receiving six proposals, has chosen Patterson Lee to do a study of the facilities. They hope to begin the study in the next month or two and have it completed by the end of 2022.

The Trails and Open Space Committee has announced that the County is proceeding with a logging operation on a county owned parcel on Edie Road in the Town of Wilton. This will help with revegetation as well as create revenue to cover school taxes that the County incurs on County owned parcels. They are also working on updating the countywide trails maps. They will be reaching out to the Towns for updated information.

County Soil & Water Conservation has trees and shrubs available for purchase as well as fish stocking.

The Town has received a resignation from Bruce Gardner from the Planning Board effective at the end of April. Supervisor Grasso said that Greg Stevens has shown interest in position, and the Supervisor would like to recommend at the next meeting that the Board vote to appoint Greg to complete the term ending 2025. The Town also received a resignation letter from Marilyn Phillips who is an Alternate on the Planning Board. Robin Sevinsky is interested in serving in this position, and the Board will vote on this appointment at the next meeting.

For the month of March, the Town account balances were \$1,650,946.71 at the beginning of the month, and \$1,622,352.90 at the end of the month.

ANNOUNCEMENTS

Town offices will be closed April 15 – 16th for the Good Friday and Easter holiday.

Spring Brush pick-up will be done the week of April 25th to the 28th. Brush should be curbside by April 24th.

The Roadside Cleanup event will be held April 23rd from 9 a.m. until noon. Volunteers will be provided with gloves, vests and trash bags. Interested volunteers should sign up by contacting Bob Killeen at (518)882-1283.

The Spring Newsletter has been mailed to residents as well as placed on the Town's website and e-mail blasted to residents. Please note the important dates listed in the Newsletter.

A draft survey has been done by EDP of the Town's Mill Pond Park. Supervisor Grasso said that the Town intends to give copies of the survey to adjoining property owners and the Town intends to place boundary markers.

The Town is drafting Park Rules and hopes to have a draft completed in the next couple of months.

Presentation by Maria Trabka, Executive Director of Saratoga Plan:

- Saratoga Plan (SP) was founded in 2003 and their mission is to preserve rural character, scenic beauty and natural habitats.
- They currently have a staff of five and they are looking to hire two additional staff.
- They have a Board of Directors that set their policies and their strategic direction.
- Saratoga Plan has helped three Charlton farms preserve their land.
- There are 24 protected areas in Saratoga County and 12 of them are open to the public.
- Volunteers maintain the trails and do the caretaking of the public preservation areas. They have about 200 volunteers.
- Staff members help people explore options for their land.
- When applications are filed, SP assists with grants applications to help cover costs of surveys, stewardship and legal costs. These costs occur even in the case of donated land.
- NYS Ag & Markets has a competitive award program, but the land has to meet certain criteria and must be suitable for the intended purpose, such as farming.
- Forest land can also be preserved.
- The minimum land to be preserved is usually 15 to 20 acres but could be less if the land adjoins other protected land or is a link to other desirable land.
- An appraiser determines the value of the land. The easement value is the difference between the unrestricted value less the restricted value.
- SP has booklets, fact sheets and holds workshops for interested landowners.
- Ms. Trabka said that an important area for conservation is areas that replenish our aquifers.

COMMUNICATIONS

Supervisor Grasso said that this past month he has received calls from residents regarding: Speeding and traffic speeds on Charlton Road and Cook Road, localized flooding on Root Road, manure on Western Avenue, and interest in the Planning Board vacancies.

The Sales Tax amount for March was \$110,588.00 which is up 16% from March of 2021.

The Town of Ballston has completed their Comprehensive Plan update and the Environmental Impact Statement. This information is available on the Town of Ballston website.

The Town Board has received the opinion letter from the ECC for the Conrad Bernard Exceptional Use Permit application.

NYS Labor Dept. has provided the Town with a guide for Municipality hiring of contractors which includes requirements for prevailing wages, etc.

Bikeatoga sent the Town a flyer regarding their program to offer free refurbished bikes, helmets and locks to anyone in Saratoga County, free of charge. Their phone number is (518)290-0746 and their website is: bikeatoga.org.

The West Charlton Fire Department sent the Supervisor their calendar of events for 2022, which include: pancake breakfast on May 1, Town wide yard sale September 12 & 17, Dinner Dance Party on September 24, Election Day Soup Sale, and Family Christmas Party on December 4.

DEPARTMENT, COMMITTEE & COUNCILMAN REPORTS

Town Clerk – Clerk Mills reported that her office took in \$625.50 for the month of March. \$559.88 was paid to the Supervisor's office as revenue, and \$65.62 was paid to other Governmental agencies. Clerk Mills said that Lita Eskin has asked the Town to notify residents that they can pick up Charlton Directories at the Town Clerk's office, as Charlton Fire District #1 did not deliver them last fall.

Planning Board: Councilman St. John said that the next Public Hearing on the Davidson application is April 18th. The Heflin application continues with no changes.

Town of Ballston Library - Councilman Tasse read the following report:

The Library anticipates that construction on the Local History Room and the LED Lighting Upgrade will begin soon. • The Library will now be providing a mix of indoor, outdoor and virtual programs. We offer several book clubs each month for children and adults. Our popular Memoir Writing Series started on April 7 in Elmer Smith Park and we will continue to offer Grab N Go kits for patrons to use at home. • The Burnt Hills-Ballston Lake Student Art Show is on display at the Library. On Saturday, April 9th teachers, artists and supporters gathered for a reception hosted by the Friends of the Library. • The Friends of the Library has been busy with several community dinners, hosting the Art Reception and now their Annual Spring Fling Raffle is going on. Raffle tickets are available for purchase through May 21. The drawing will held at the Spring Book Sale which will run May 19-21.

Constables – In March, there were 3,284 miles traveled, 27 patrols, 12 complaints received, 7 911 calls and 1 EID responded to, and 43 tickets were issued (18 on Route 67).

Dog Control – In March, there were 8 calls received.

Highway – Superintendent Marshall Heritage submitted the following report for the month of March:

Mr. Heritage reminded residents that any resident with large amounts of brush can contact the Highway Department to have a truck delivered that residents can load brush onto.

Acoustical panels – Councilman Robbins said that he has finished the installation of fabric blinds in the Town Hall meeting room.

Community Project Funding – Councilman Robbins said that the Town has been made aware of a Federal grant opportunity from Senator Tonko. Even though the Town has received late notice, the Town plans to apply by the April 15th deadline. If awarded, the Town plans to use the grant for the Community Center renovations.

Charlton Seniors – Councilman Robbins will speak at their meeting on April 13th. The meeting will be held at the Community Center.

Founders Day – Councilman Robbins said that planning is under way for the Founder's weekend activities including Party in the Park. If anyone would like to volunteer to help, they can contact Councilman Robbins.

Technology Committee – Councilman Tassè said a new pc, laptop and docking station have been purchased and installed for employees at Town Hall.

Water: Councilman Glavin discussed 2 resolutions that would be voted upon this evening that involved the Town Water System. The first resolution is a resolution to hire a contractor, MJR Services, to complete and test the back-up chlorination system at the pump house. The second resolution authorizes hiring Environmental Design Partnership (EDP), the Town's engineering firm, to evaluate and propose a second water source and tie-in location into the Town's system. Additionally, the Town is requesting EDP to conduct a conditional analysis of the existing system and inform the Town via report, of additional risks and liabilities associated with the system, both current and potential future, so that the town can be proactive in addressing any of our top risks.

WHEREAS, the Town Board has received documentation and performed an initial review of the application, and is required by statute to schedule and hold a public hearing with respect to the project to consider public input on the matter.

WHEREAS, the Town Board believes MJR Construction Services to be of known quality, and the best choice to perform the work, at a reasonable cost and best value and expense to the Town.
