SUPERVISORS REPORT

For the month of June, I attended 3 Town meetings and 3 County meetings. Some of the highlights of the month:

- Attended normal Town and County meetings
- Attended all the Founder's Day activities
- Attended the Year of the Seniors in Saratoga Springs

Supervisor Grattidge said that the Saratoga County sponsored a Year of the Senior celebration on June 26th in Congress Park in Saratoga. About 2,000 seniors attended and it was a very successful event.

Supervisor Grattidge said that when Saratoga County sold the County landfill, they decided to do a profit sharing with the Towns in the county. They will base the amount of money on the assessed value and population of the Towns and each year the amount will be based on the previous year. Charlton's share this year is \$32,501.93. This money was not included in our 2019 budget.

Supervisor Grattidge said that the Town has been allocated \$20,409.74 from New York State from their Extreme Weather Recovery Fund for a storm that occurred last winter. This money was not included in the 2019 budget, and will be used by the Highway Department for road construction/maintenance.

Supervisor Grattidge confirmed that the Board received the financial reports for the month.

The Highway Superintendent said that the paving on Crawford Drive is projected to be done in the week of July 22nd. Supervisor Grattidge said that the Highway Superintendent needs to follow up with DOT to have the batteries replaced in the traffic light at routes 147 and 67.

Ambulance Advisory Committee – Councilman Robbins said that the Committee members and a few of the Town Board members plan to tour the Galway EMS facility on July11th.

BHBL Community Library – Colleen Smith gave the following report:

- 1. Library staff and Friends of the Library marched in the Annual BH-BL Annual Community Flag Day Parade to promote the library's Summer Reading 2019 program. This year's program theme is A Universe of Stories. You can still register for the program. Call or stop by the library if you need assistance!
- 2. The library's Summer Reading Kickoff Party on Monday June 24 in Jenkins Park was a tremendous success with 250 people attending. The event started off at 4:00 pm with Story Time in the Park and offered live music, refreshments, face painting, reading to therapy dogs, and a bookmark craft station. Thank you to the Friends of the Library for volunteering and providing funding for the refreshments.
- 3. The library is offering some terrific programs for all different ages as part of the Summer Reading program, e.g., Meet the Authors Becky Albertalli & Jennifer Dugan, Our Sun-sational Star, Teen Cookie Decorating, Finch Robot Races, Real Food Fast with Jodi Fitz, and Essential Oils 102. Register online or call the library to reserve your spot.

Zoning – Councilman Ranaletto reported that the Zoning officer has been busy working of getting junked cars removed from Division Street. A building permit was issued for the final lot in Deer Run. Many swimming pool applications have been received. There has been a lot of attention paid to the Orzelek farm which is for sale.

ECC – Marv Schorr, Chairman, appears to be recovering.

Constables – In June, there were 35 patrols, 17 complaints received, 12 911 calls, 0 accidents & 4 EMT/Fire call responded to. 2,847 miles were traveled, and 50 tickets were issued (12 issued on Route 67).

Dog Control – In June, there were 7 calls received, 5 pertaining to other animals, and 3 expired licenses followed up on.

Planning Board – Councilman Grasso said that the Board received an application for a 3 lot subdivision on Waite Road, each lot being 5 acres.

Councilman Grasso said that he spoke with Dave Brennan, Attorney for Verizon, and he indicated that they are still working on revised application materials for their dormant application for a cell tower at 764 Charlton Road. They were not ready for the meeting tonight and would like to make a presentation at the August 12th Town Board meeting.

Councilman Grasso said that he spoke with Rick Hyde from St. Mary's Hospital regarding the new Urgent Care facility in Charlton. They are hoping to wrap up construction this month, then plan to take a month to install equipment and open by early fall. They are adding a low landscape wall which the Zoning Officer did not have issues with.

Councilmen Grasso and Robbins, along with Highway Superintendent Heritage did a walk-through of Elmer Smith Park earlier this evening to scope out a possible trail project that they would like to submit to the County's trail grant program. It is a matching grant program with up to a \$10,000 award. The Town's contribution can be in-kind services or a cash match. Councilman Grasso gave the Board a sketch plan of the proposed trail. The trail would start at the existing parking lot and would loop around the ball field, through the open space with a spur that would go to the Conde Cemetery. Based on the field walk, the Councilman would like to make a few modifications to the sketch. His rough estimate for materials was \$8,000 but after the field walk, feels that there is drainage work that needs to be done and additional material cost for it of \$1,000, bringing the total for materials to about \$9,000. He also estimated the in-kind cost of the Highway Department labor cost to do the work and it would also be about 8 or 9 thousand dollars. The Town Board was in agreement that Councilmen Grasso and Robbins should proceed with filling out the grant application which is due by July 12th. The Board agreed that it is good to make the pathway and park more accessible. There was also concern about vandalism to the Conde Cemetery. The Board felt that if there was more activity in the Park, it could cut down of vandalism

BHBL Summer Rec Program – Andrew Haluska, Director said that there are children enrolled in the program from the Towns of Clifton Park, Glenville, Ballston, Charlton and a few from Amsterdam. They are serving about 118 children up from 82 last year. There are 25 children from Charlton, about 22% of the total attendees. This year they are allowing parents to pick certain weeks instead of committing to the entire time. The program has been revamped with new Directors of sports, recreation and arts. All counselors are good role models, good students and athletes. The program provides transportation to students, and the program must reimburse the school district at the rate of \$3.52 per mile. The total budget is \$64,000 for the summer. The typical cost for the summer is \$385 and the program will run from July1 through July 26th. They are thinking of adding a STEAM program next year. Supervisor Grattidge offered help to Mr. Haluska to apply for money that is available through the Saratoga County Youth Bureau. Charlton donates \$1,000 annually towards the program, The Town of Ballston \$9,000 and the Town of Glenville \$5,000.

Account Clerk Report from Cara Parks - For the quarter ending June 30, 2019, the town has reached 31% of the Mortgage Tax budgeted amount. On May 22, \$62,899.16 was received by the Town as mortgage tax distribution. The town has received 46% of budgeted Sales Tax revenue from the county. A new highway truck costing \$160,806.00 was paid for in March. Reimbursement in the amount of \$100,000.00 was received from DASNY on May 16, which represents payment towards the new highway truck. On May 9 – 10, I attended the Association of Towns, 19th Annual Town Finance School in Saratoga Springs, along with Joe Grasso and Dave Robbins. We received helpful information on formulating a multi-year plan, especially as it relates to budget season. Going forward, I will be making use of OpenBookNewYork.com to develop greater financial analysis to present to the Board at appropriate intervals.
