The Town Board will hold a Budget workshop on October 3rd at 7pm

The Town Highway Department will be doing fall brush pick-up the week of October 3rd - 7th.

The Town is sponsoring Bulk Item Drop-off for residents from Monday October 24th until Saturday October 29th at the Town highway garage on Jockey Street. The hours will be Monday through Friday, 8:00 a.m. until 4:00 p.m, and Saturday 8:00 a.m. until noon. More information will be in the Fall newsletter and is available on the Town website.

The Town Highway Department will be doing bagged leaf pick-up October 31st - November 4th.

The Town offices will be closed October 11 for Columbus Day. The Town Board meeting is Tuesday Oct. 12.

The Fall newsletter was sent to the printer last week and will hopefully be in mailboxes by week's end.

Councilman Glavin said that water restrictions have been lifted for Town water customers. He also noted that September 30th is the final day to pay the 2022 Town water bill. Any outstanding water bills will be sent to the County to be re-levied on the January tax bills

SUPERVISOR REPORT

Supervisor Grasso said that he has issued the August financial reports to the Town Board. He also reported the following:

Over the past month, the account balance totals have risen \$11,639.54. Bond payments begin coming due in September. Par through August is 67%.

General Fund

Revenues are at 72% of budget. Expenses are at 55% of budget.

Highway Fund

Revenues are at 64% of budget. Expenses are at 71% of budget.

Note that the Highway revenue does not reflect the \$100,000 allocation of ARPA funds. Also, for Highway, we haven't received the CHIPS reimbursement yet which should show up in the 4th guarter.

The best score to receive is No Designation or a low numeric score. He is happy to report that the Town received a No Designation score for the Fiscal Stress Analysis, as well as a No Designation score for the Environmental Stress Analysis.

RESOLUTION NO. 158 September 26, 2022

RESOLUTION ESTABLISHING LOCAL LAW #1 OF 2022 REGARDING RESTRICTIONS AT THE TOWN OF CHARLTON BRUSH AND LANDSCAPE DISPOSAL FACILITY

WHEREAS, the Town allows residents the ability and right to dump brush, leaves and grass clippings at the Town's Brush and Landscape Disposal Facility; and

WHEREAS, the Town has become aware of the growing problem of contractors and nonresidents dumping building material and other unacceptable items on the premises; and

WHEREAS, the Town Board caused to have drafted a local law to address the issues, and believes it to be in the Town's best interest to establish penalties for such offenses, and to enact the attached Local Law in furtherance thereof; and

WHEREAS, pursuant to New York State Law, the Town Board scheduled and held a Public Hearing on said local law on September 26, 2022, wherein the Public was invited to attend and provide comment thereon.

NOW THEREFORE, BE IT RESOLVED, the Town Board of the Town of Charlton, after due deliberation, hereby authorizes the Town to adopt and does hereby adopt Local Law #1 of 2022, entitled "A LOCAL LAW REGARDING RESTRICTIONS AT THE TOWN BRUSH AND LANDSCAPE DISPOSAL FACILITY LOCATED ON NYS ROUTE 67 IN THE TOWN OF CHARLTON", restricting the uses of the Town Brush and Landscape Disposal Facility and assessing fines for violations thereof, a full and complete copy of which is annexed hereto; and

BE IT FURTHER RESOLVED, that the Town Clerk be and she hereby is directed to enter said Local Law in the minutes of this meeting and in the Local Law Book of the Town of Charlton and to give due notice of the adoption of said Local Law to the Secretary of State of the State of New York, and publish same as is required by Law.
