### Fall Brush Pick-Up

The Highway Department will be picking up brush from Summer storms and Fall clean-up during the week of October 22. As there will be only one pass-by, please be sure to have your brush out by Sunday night (Oct. 21). Please put the cut ends toward the road and be sure all material is free of roots, dirt and any foreign objects (ie, nails, wire, any metal, etc). PLEASE **NOTE:** Residents with a larger-than-average load of brush (more than what will fit in a pick-up truck), should contact the Highway Dept at (518)399-3425.

### Leaf Pick-Up (NEW this year!)

The Highway Department will be picking up bagged leaves (biodegradable bags only ) during the week of October 29th. Please have your bags curbside by October 28th.

# News From Town of Charlton Officials

## Assessor's Office

As we enter the fall season it is time to start thinking about exemption forms. There have been some changes that many residents and new homeowners are not aware of. In May of 2016, the regulations for the Basic STAR Exemption have changed. New STAR applicants (anyone who purchased their home after March 1, 2015) will receive a credit in the form of a check directly from New York State instead of receiving a school property tax exemption. The amount of your STAR benefit is the same regardless of how you receive it. The eligibility requirements remain the same for both the STAR credit and the STAR property tax exemption. To receive the STAR credit or exemption, you must own your home and it must be your primary residence.

Current Basic and Enhanced STAR exemption recipients will keep their exemptions as long as they continue to own their current home.

New Basic and Enhanced STAR applicants need to **register** with New York State Tax Department to receive a STAR check. You can visit <u>www.tax.ny.gov</u> or call (518) 457-2036 for more information.

The new STAR regulations do not affect the additional exemption for Low Income Seniors. The income limit for this exemption varies with the school district. Burnt Hills: \$37,400; Ballston Spa and Galway; \$32,400; Scotia/Glenville: \$27,999; If your income is below the level associated with your school district as reported on your 2018 taxes, and one owner has reached or will reach the age of 65 by December 31, 2018, it is in your best interest to apply for this exemption. The income requirements are a little more involved so please stop into the office and pick up a form. (Form RP467)\* Please note that we need your most recent tax return, which will be 2018, for this type of exemption.

### New for 2019-2020 School Year:

Beginning with the 2019-2020 school year, the Tax Department will annually determine income eligibility for all potential Enhanced STAR recipients. Enhanced STAR recipients will fall into three catagories:

- Property owners who were participating in the Income Verification Program (IVP) for the 2018-2019 school year. Existing IVP participants will not need to take any action for the 2019 assessment roll. If the Tax Department needs additional information, you will be contacted directly from the State.
- Property owners who received Enhanced STAR in 2018, but are not in the IVP program. You will be required to provide the Assessor's Office with the following:
- Form RP-425-Rnw Renewal Application for Enhanced STAR Exemption for the 2019-2020 School year;
- Form RP-425-IVP *Application for the Enhanced Star Income* Verification Program, and
- either a copy of your 2017 state or federal income tax return of Form RP-425-Wkst.
- Property owners who received the Basic STAR in 2018, and who are applying for the Enhanced STAR exemption beginning with the 2019-2020 school year. You will submit the following to the Assessor:
- Form RP-425-E Application for Enhanced STAR Exemption for the 2019-2020 School year;

- Form RP-425-IVP Application for the Enhanced Star Income Verification Program, and
- either a copy of your 2017 state or federal income tax return of Form RP-425-Wkst.

## TAX COLLECTOR

Property Tax Bills will be mailed out by January 1, 2019. If you have not received your tax bill be the end of the first week in January, please call or email the Tax Collector's office. Beginning Thursday January 3, 2019, the Tax Collector's office will be open for in-person payments Tuesdays, Thursdays, and Saturdays from 9:00 am to 12:00pm for the month of January. February and March payments can be made via mail or by appointment. For payments and Property Tax questions after March 31, 2019, please contact the Saratoga County Treasurer's Office at 518-884-4724.

Note : Payments made through online banking or online bill-pay services can take 10-14 days to be processed before being mailed. As these services do not have legal USPO Postmarks, Tax payments made via online services are receipted on the date they are physically received by the Tax Collector from the USPO. ## **EMERGENCY PLANNING**

### Alert Notification - Sign-up today!

CodeRED is a FREE emergency notification service provided to all residents that will notify you of emergency information through phones calls, **TEXT** messages, social media and the CodeRED Mobile Alert app. The CodeRED system will be used to send alerts for such things as: road closures, criminal activity, wildfire alerts, emergency evacuations and crisis updates, missing children and any other local emergency information that may impact your safety. ## DOG CONTROL

New York State Law requires that **all dogs be licensed** and be vaccinated for rabies. Licenses can be purchased at the Town Clerk's office. The fee is \$8 for spayed /neutered and \$13.50 for unsprayed/unneutered dogs.

### Water Payments

Water Bills can be paid to Charlton Water District #1 until October 15th. After this date, delinquent water bills are sent to the county to be added to the tax bill for the following year.

### Water Adjustments for Closings Procedure:

If you are requesting a water adjustment for a closing and the water office is closed, please contact (518) 857-8974. Please provide the address of the property, property owners name, meter reading, contact person's name, telephone number and fax number of where to send the adjustment. This information can either be texted or left on the voice mail of the above telephone number.

### Flushing

Hydrant flushing will begin this fall throughout the entire water district. Flushing can happen at anytime, anywhere in the district. Hydrant flushing will continue throughout the district until the weather changes and the hydrants have to be winterized.

## BUILDNG & ZONING DEPT

Fall is quickly approaching and it has been a busy summer for the Building and Zoning Department with a number of new homes, additions and of course swimming pools. Please remember to contact us when your project is complete for a final inspection. I never miss an opportunity to remind you to change your smoke detector batteries and while you are at it if they are more than ten years old it might be a good time to upgrade. Last but not least the next time you pull up to your house try to imagine an emergency responder trying to find your house number after dark. If you can't find it neither can they. Please make sure you have numbers visible from the road after dark to assist those trying to assist you.

## BULK ITEM DROP-OFF

The Town of Charlton, in partnership with County Waste and JDog Junk Removal, announces the town-wide bulk item Drop Off. You may drop off acceptable items at the Highway Garage beginning Monday, October 15th through Saturday, October 20th from 8AM - 3PM. Residents (proof required) can bring bulk items during these times and our highway staff will assist by loading the items into the rollaway.

Residents who prefer not to drop off, or do not have the ability to bring their items to the highway garage, can contact either County Waste 877-7007 or JDog 944-0901 directly to make arrangements to have their items picked up. The Town has negotiated a discounted price with both companies, however the **resident is responsible for payment** of this service and will need to work directly with either company.
