The Agenda Meeting of the Town Board of the Town of Charlton, Saratoga County, New York was held at the Charlton Town Hall, 758 Charlton Rd, Charlton, NY and called to order by Supervisor Grattidge 7:30 p.m. to set the agenda for the December 14th meeting.

The Town Offices will be closed for the Thanksgiving holiday on November 26th and 27th.

DISCUSSION

The Sales Tax received this month was \$113,845.00 and overall is down approximately 5.5% for the year. The Mortgage Tax received was \$16,632.30. The six month distribution amount of Mortgage Tax was \$112,019.69.

The Board has received a notice of resignation from the Account Clerk informing them that her final day will be January 8th. The Town Board will post the position and try to find someone in December so that there can be a transition period. The Board has decided to change the position back to part time, 10 to 20 hours per week with an hourly rate of \$23 to \$26 per hour depending on experience. The County has put together the job description for an Account Clerk typist part-time and has posted it with a due date for resumes by December 2nd. The position would be a Town Board appointment and would not be a civil service position. There is a possibility of interest from an Account Clerk in a neighboring town.

Councilman Grasso said that the Burnt Hills Ballston Lake Business and Professional Association will be holding their Annual Talk of the Town Meeting and has invited a representative from the Supervisors office to speak. It will be a virtual meeting on-line on January 6th at 9 a.m. The Supervisors of the Towns of Ballston, Charlton, Clifton Park and Glenville are asked to speak about the state of their Towns.

Councilman Robbins said he is working with the Seniors to plan the tree lighting ceremony on December 6th. Supervisor Grattidge said that with Covid rates rising, he would suggest that the event not be held this year. Councilman Grasso agreed that the event should be cancelled.

Councilman Grasso said that the Town had previously solicited bids from Odorless Sanitary Cleaners, Charlton Septic and Nichol Septic for the Community Center septic system. The only company that submitted a bid was Odorless. The bid was for just under \$25,000 and included a \$7,500 deduct alternate to change the design of

the tank and the rail system. The Councilman has discussed this with the Town Engineer and they feel confident that the Town should take the deduct alternate and go with the cheaper system because of the low volume of usage at the Community Center and because money is tight right now and this is an unplanned expense. Councilman Grasso would like to have a resolution at the next meeting to award the construction of the new septic system to Odorless Sanitary Cleaners for just under \$17,500 and also include \$2,500 for any incidentals as well as the electrical service. He said that he would like to have a dedicated electric service to our pump panel and alarm, etc. He will work with the Town Attorney on getting the resolution done. He has not heard from the Fire Department as to when the work needs to be done, but they will need to coordinate the work with them.

Councilman Robbins said that he and Jay Wilkinson have looking into options to improve the acoustics in the Town Hall Meeting Room. The quotes are quite pricey to do the whole room, so they are looking into doing the work in phases and see how that improves the sound.
