**PUBLIC HEARING

Regarding the establishment of a Local Law providing for prior written notice of the existence of a defective or hazardous condition existing on Town owned and/or maintained property

Present: Councilman Grasso, Councilwoman Heritage, Councilman Ranaletto, Councilman Robbins, Supervisor Grattidge, Town Clerk Brenda Mills, Attorney Craig.

The Public Hearing began at 7:15 p.m. at the Charlton Town Hall. Supervisor Grattidge stated that this is a Public Hearing regarding the establishment of a Local Law providing for prior written notice of the existence of a defective or hazardous condition existing on Town owned and/or maintained property.

The Town Clerk read the following Legal Notice and confirmed that it was published in the official newspaper, The Daily Gazette on February 13, 2019:

Supervisor Grattidge said that the Loss Claims Specialist from the Town's Insurance Company suggested that the Town have this Local Law in place to lessen the Town's liability. The representative provided a template with the language for the Local Law.

Attorney Craig said that it is a very good idea to follow the suggestions of the Insurance Company so that they do not have a reason not to cover an incident. It is a little more protection for the Town, but the Town still needs to fix things when they are brought to the Town's attention.

The Floor was opened to public comment:

Bert Wilson, Cherry Lane, said that he arrived late for the Hearing and asked for a summary of what the purpose of this law was. Attorney Craig explained that this is to give the Town a little more protection from

civil lawsuits for damages or injuries suffered based on damages to our property. This Local Law requires that we have written notice beforehand and that will give the Town a reasonable amount of time to correct that defect before a suit can be filed.
